Compliance

The basic building blocks of professional compliance management are detailed guideline texts: These complex texts, often with more than 100 pages, can be digitally and functionally mapped in the WTS DECISIONmanager. Moreover, through an interactive use, handling in operational business becomes more practicable. The user does not have to know the guidelines itself in detail, and the links to individual documents and postings are automatically traced. In the end, an opaque black box turns into a transparent compliance tool that ensures that comparable issues are treated consistently.


Transparency & Flexibility

The results of WTS DECISION manager are comprehensible, documented decisions for tax issues on basis of individual facts.

Indeed everywhere: Tax decisions are made at many points within a process: starting with the validation of documents, contracts, individual inquiries to decisions about the relevant account for posting a matter.

Due to the central modeling of decision rules, relevant logics are only maintained at a single central point and are then available in all applications.

As a result, prompt adaptation of decision-making rules for the implementation of new legal requirements and on the basis of the latest case law can be ensured and an inconsistent database with ambiguous or contradicting rules can be avoided.



Time Advantage

Because we add tax knowledge into clearly defined decision-making rules with the WTS DECISIONmanager, tax competence is available company-wide. Above all, people with no knowledge of the subject are accompanied through the decision-making process using the easily understandable questions.

The time advantage lies on both sides: The tax departments are not approached on the same questions over and over again in standard processes. Business colleagues, on the other hand, do not have to grapple with complex and difficult to-understand guidelines or look for suitable and free contacts in the tax department.

In addition, the WTS DECISIONmanager offers an interface for the automated import and reliable processing of mass data. The checked data can later be visualized and analyzed via a dashboard.

Platform

There is the option of either using the client's existing IT systems / platforms as a basis or the ONEwts platform.
